- Prospective bidders should have completed within two (2) years from date of submission and receipt of bids, (1) similar contract and the contract amount should be equivalent to at least 50% of the ABC for the items. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders. Delivery of goods required by thirty (30) calendar days.

2. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act 9184 otherwise known as the "Government Procurement Reform Act".
3. Bidding Documents through Electronic Form "CD" may be purchased by interested bidders from the address listed below and upon payment of a non-refundable fee in the amount indicated in the above table. It may also be downloaded from the website of the Philippine Government Electronic Procurement System (PHILGEPS) and the website of the Schistosomiasis Hospital: [schistosomiasishospital.doh.gov.ph](http://schistosomiasishospital.doh.gov.ph), provided that bidders shall pay the non-refundable fee for the Bidding Documents not later than the date of bids submission.

It may also be downloaded free of charge from the website of the PhilGEPS provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.


4. Bids must be duly received by the BAC Secretariat at the address below on or before the deadline of the submission of bids stated below. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

The Schistosomiasis Hospital reserves the right to accept or reject any and all bids, declare a failure of bidding if the funds/allotments for the program/project/activity have been withheld or reduced through no fault of the procuring entity, to annul the bidding process, and to reject all Bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
