1. The Schistosomiasis Hospital, through the Bids and Awards Committee (BAC) invites contractors to bid for the hereunder projects:

Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The prospective bidder must have an experience of having completed at least one (1) contract that is similar to the contract to be bid, and whose value, adjusted to current prices using the PSA consumer price indices, must be at least fifty percent (50%) of the ABC to be bid, provided, however, that contractors under Small A and Small B categories without similar experience on the contract to be bid may be allowed to bid if the cost of such contract is not more than fifty percent (50%) of the Allowable Range of Contract Cost (ARCC) of their registration based on the guidelines as prescribed by the PCAB. Prospective bidders shall have a Valid Philippine Contractors Accreditation Board (PCAB) license and registration for License.


The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act."
4. Bidding documents through Electronic Form "CD" may be purchased by interested bidders from the address listed below and upon payment of a non-refundable fee in the amount indicated in the above table. It may be downloaded from the website of the Philippine Government Electronic Procurement System (PHILGEPS) and the website of the Schistosomiasis Hospital, provided that bidders shall pay the non-refundable fee for the Bidding Documents not later than the submission of their bids.

The Schistosomiasis Hospital reserves the right to accept or reject any bid, to declare a failure of bidding if the funds/allotments for the program/project/activity have been withheld or reduced through no fault of the procuring entity, to annul the bidding process, and to reject all Bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
